

Disclosure in accordance with the "Code regarding the protection of personal data"

Italian Legislative Decree n. 196/2003

1. Source of personal data

The personal data in possession of Farmhouse Guinzano are collected directly by Interested at the time of registration or by communication of personal data carried out by data transmission

2. purpose of the treatment

The personal data are processed for the following purposes:

- a) fulfill the legal obligations deriving also from local and municipal regulations as well as rules of civil and criminal law, in order to fulfill any contractual obligations towards the party concerned, the credit protection and debt management.
- b) functional activities to Farmhouse Guinzano, carried by letter, telephone, advertising, automated communication systems, etc., in relation to which the subject has the right to give or deny consent. Each subject has the right to refuse or revoke then, at any time, your consent to treatment, without adverse consequences in the relationship and / or for the performance of services requested by you before withdrawal.

3. Method of data processing

In relation to the purposes described in the previous section, the processing of personal data takes place using manual, computer and telematic tools, with logics strictly correlated to the aforesaid purposes, and in any case in order to ensure the security and confidentiality of the data.

4. Categories of data to be processed

In relation to the purposes described in paragraph 2 above, Farmhouse Guinzano processes personal data other than "sensitive" (ie personal data revealing racial or ethnic origin, religious beliefs, political opinions, the data regarding a the state of health, sex life, etc..) and "judicial". In particular, the processing performed by Farmhouse Guinzano refers to personal data such as name, address, etc.. For these reasons, please do not communicate to Farmhouse Guinzano personal data "sensitive" and / or "judicial".

5. Obbligo o facoltà di conferire i dati

With regard to the data that we need to know in order to fulfill the obligations required by laws, regulations and EU legislation, or provisions issued by authorities empowered by the law and organs of vigilance and control, their missed giving from You involves the impossibility to start or continue the transaction, to the extent that such information are required for the same.

Your data will not be distributed by us, this being intended to give knowledge to indeterminate subjects in any way, also by making them available for consultation. Your personal data may be communicated by us, this being intended to give knowledge to one or more specific subjects, in the following terms:

- to subjects who can access the data under provisions of the law, regulation or legislation, within the limits set by such regulations;
- subjects that will need to access your data for purposes ancillary to the relationship between you and us, within the limits strictly necessary to carry out auxiliary tasks (for example credit institutions);
- • to our consultants, within the limits necessary to carry out their duties in our society, subject to our letter of appointment which imposes obligation of confidentiality and security.

6. Rights of the the Interested

We inform you, finally, that the legislation on protection of personal data gives to interested the possibility to exercise specific rights. In particular, the interested party may obtain:

- a) confirmation of the existence of data concerning him, even if not yet recorded, and their communication in intelligible form;
- b) information about the origin of personal data, the purposes and methods of processing and the logic applied in case of treatment carried out with the aid of electronic instruments;
- c) indication of the identity of the holder and the manager and the subjects or categories of subjects to whom the personal data may be communicated or who may become aware of;
- d) the cancellation, transformation into anonymous form or blocking of the data processed in violation of the law, as well as updating, rectification or, when interested, integration of data.

The interested party may also object, for legitimate reasons, the processing of personal data concerning him. It may also object to the processing of personal data for the purposes of information activities and initiatives for the promotion and presentation of Services and products of Farmhouse Guinzano.
